Agreement between BodyMindLife Group Pty Limited (BodyMindLife) and XXX (The Hiree)

1. OVERVIEW

BodyMindLife has agreed to hire a space to The Hiree to hold a workshop or event. This agreement outlines the payment terms and the operational and other requirements of each party. Both parties should ensure they read this agreement before signing and BodyMindLife will not confirm the hiring of the space until this document is agreed and signed.

2. ROOM HIRE DETAILS

- The hiree will have access to the space and for the purpose outlined in Schedule A
- The hiree agrees that the event will finish on time as per Schedule A. Failure finish on time may result in a penalty of \$50 for every increment of 15 minutes the event runs over
- The hiree understands that BodyMindLife may be running their own events and classes at the same time of the room hire and to ensure that BodyMindLife's operations will not be interrupted by the event outlined in Schedule A or the hiree's attendees, contractors or employees.
- BML staff and Teachers receive 20% on full price half day / full day hire
- Booking a block of 5 treatment room sessions attracts 10% discount

3. PAYMENT

- The hiree will pay the Fee as outlined in Schedule B
- A 33% deposit is required on booking. This deposit is non-refundable but can be transferred to a future booking in the event of a date change (and outside of 7 days prior to the event)
- Full payment is required 7 days prior to the event. No refund or transfer of funds to a future date is applicable within 7 days of the event.
- Payment can be made by EFT or credit card. An invoice will be supplied.

4. INSURANCES & OTHER COMPLIANCE REQUIREMENTS

- The hiree acknowledges that they (or their teacher(s)) have all required qualifications and insurances required to teach the content of the workshop / run the event. This includes but is not limited to the following:
 - Current Professional Indemnity Insurance
 - Current Public Liability Insurance
 - Current First Aid Cert + CPR
 - Certification (eg Yoga Alliance or Yoga Australia)
- BodyMindLife shall have in place at all times during the Agreement a policy of public liability insurance for a sum not less than AUS\$20,000,000.00.
- The Hiree acknowledges and agrees that BodyMindLife shall not be responsible for any loss or damage or injury to the Business, its employees or agents unless caused by the negligent act or omission of BodyMindLife in the provision of the Services.
- The Hire shall be responsible to BodyMindLife for any loss of or damage for a sum of AUS\$1,000,000.00 to the Plant and Equipment (fair wear and tear excepted) caused by the act or omission of the Hiree (or its employees or agents) during the event.
